### Fall Grant Recipients

WBCF is pleased to announce its Fall 2009 grants totaling \$1,013,252 to qualified 501 (c) (3) organizations (or governmental entities) serving Wythe County and Bland County Virginia, that support, promote and/or further the Foundation's mission. The funds are awarded to: Mountain Community Action, Inc., \$31,311 for food, clothing, dental, and medical transportation; One-on-One Literacy Program, \$10,948 to expand the "What to Do When Your Child Gets Sick" program; Brain Injury Services of SWVA, \$25,377 for direct services; Wythe County, \$277,000 to equip emergency vehicles; Mount Rogers Health District, \$232,632 for Fit for Life obesity program; Town of Rural Retreat, \$30,000 for planning grant for health, fitness, and recreation; Crossroads Shelter, \$19,000 for case management for homeless; Family Resource Center, \$24,000 operational expense for Lester House Child Advocacy Center; Wythe County Public Schools Foundation for Excellence, \$206,275 for summer enrichment and classroom grants; Bland Ministry Center and Dental Clinic, \$43,224 for Locum Tenens dentist; Town of Wytheville, \$66,000 for TRACK (Tracks, Ridges, & Active Caring Kids) Trail; Town of Wytheville, \$30,000 for Pass Plans for Wythe and Bland low income families to use the Wytheville Recreation Center; and Wood's River Chapter American Red Cross, \$28,485 to teach ninth graders CPR/First Aid.
